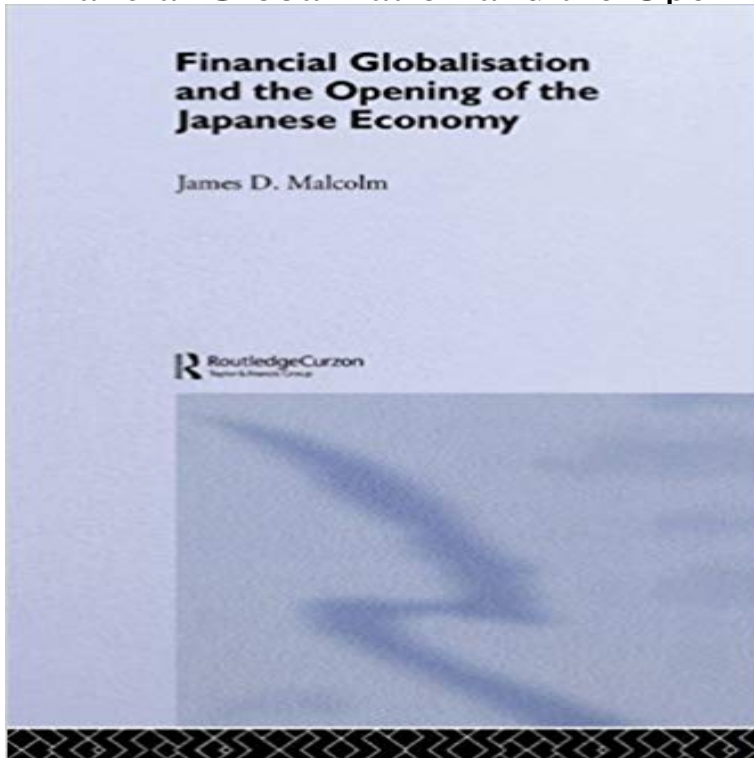


Financial Globalization and the Opening of the Japanese Economy
