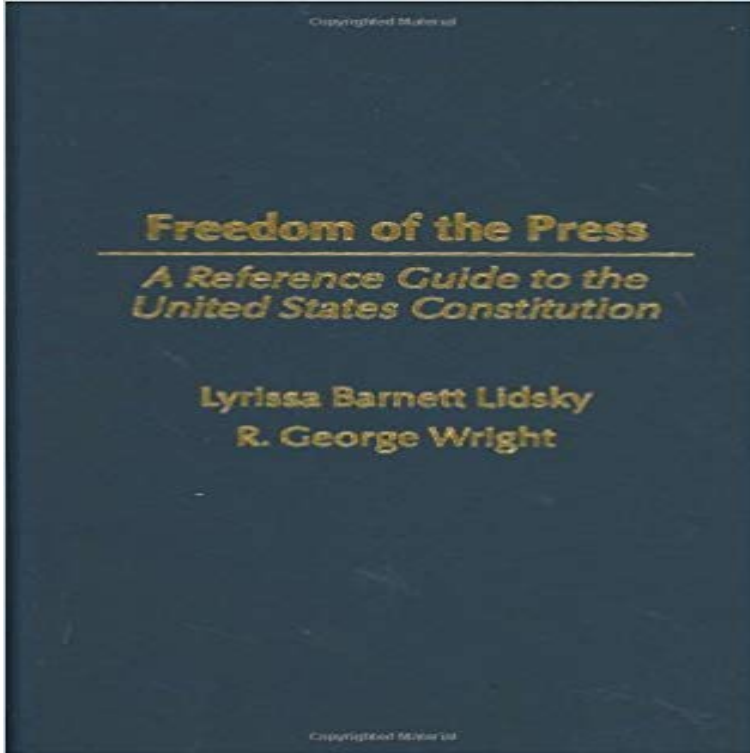


# Freedom of the Press: A Reference Guide to the United States Constitution (Reference Guides to the United States Constitution)
