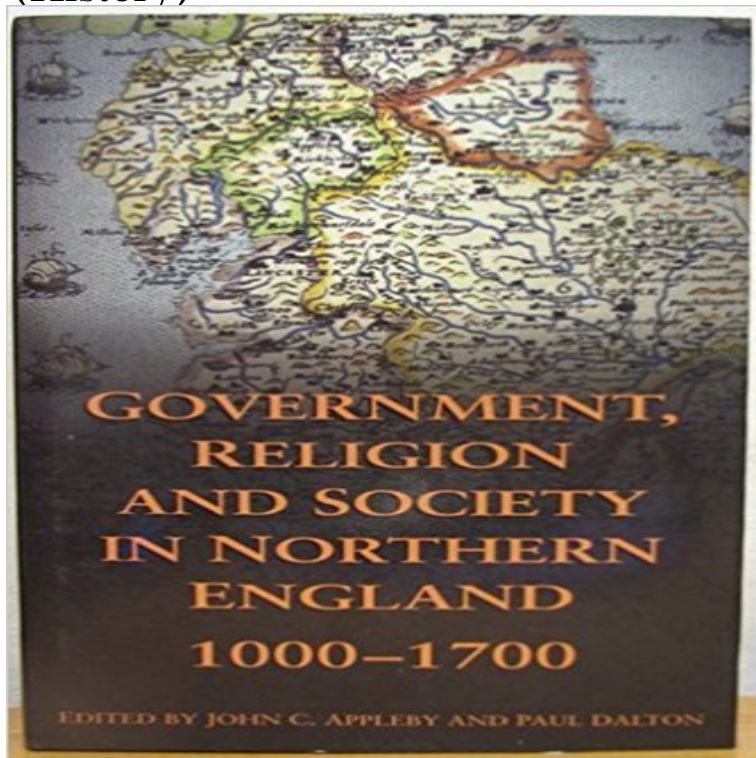


## Government, Religion and Society in Northern England, 1000-1700 (History)
