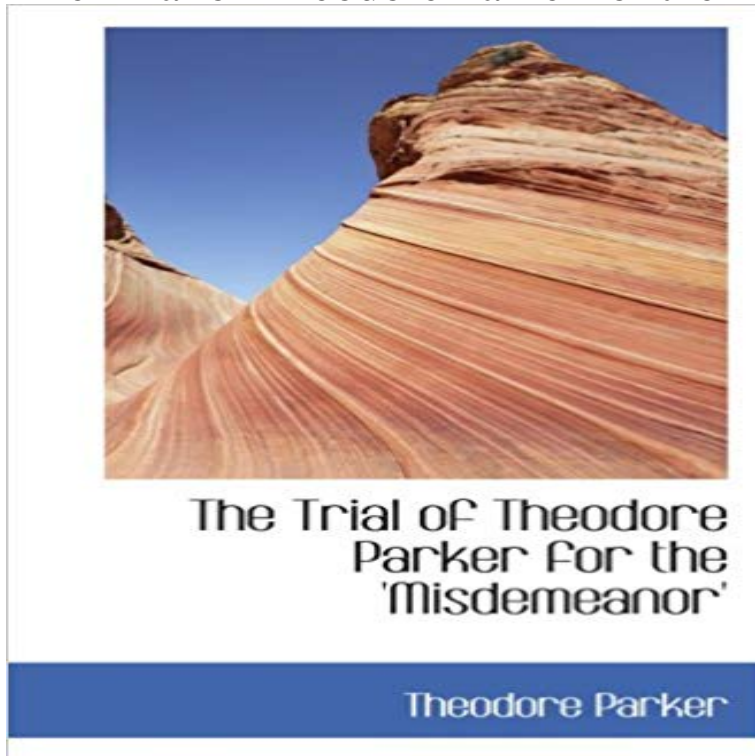


# The Trial of Theodore Parker for the Misdemeanor
