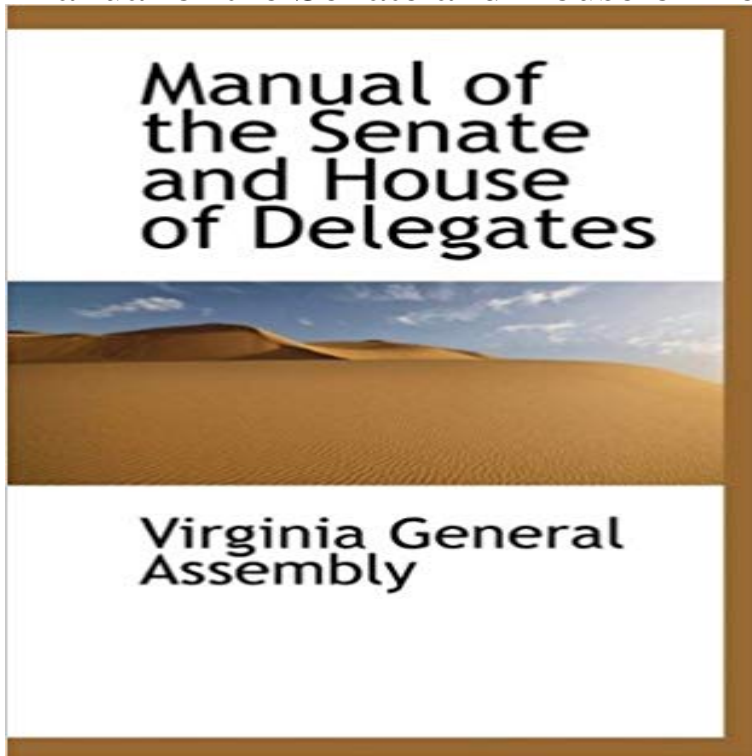


# Manual of the Senate and House of Delegates
