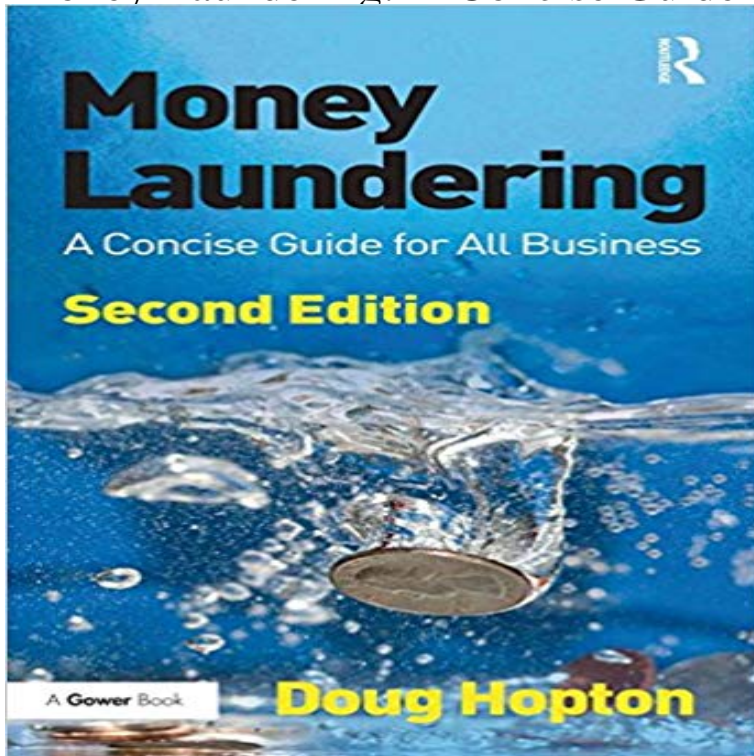


Money Laundering: A Concise Guide for All Business
