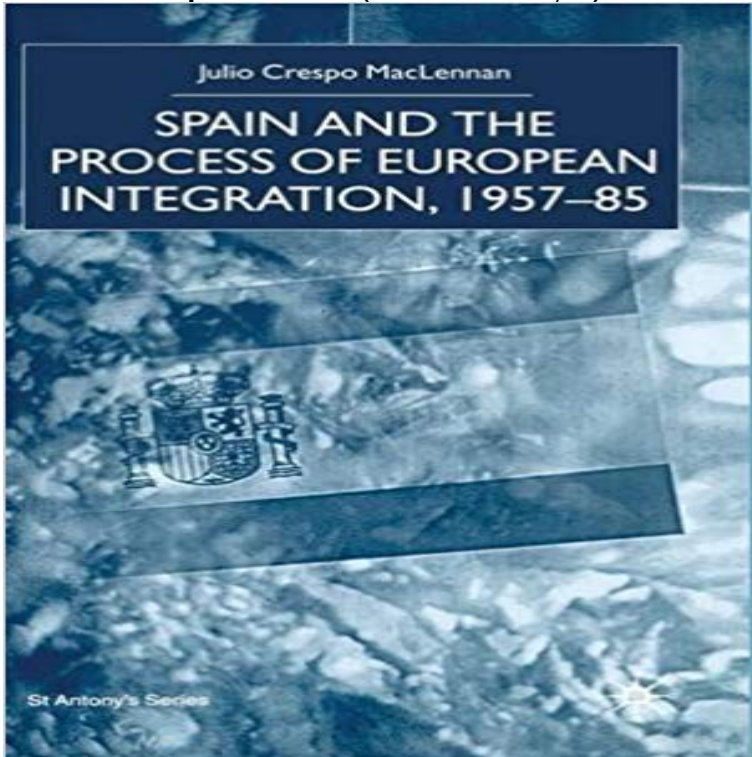


Spain and the Process of European Integration, 1957-85: Political Change and Europeanism (St Antonys)
