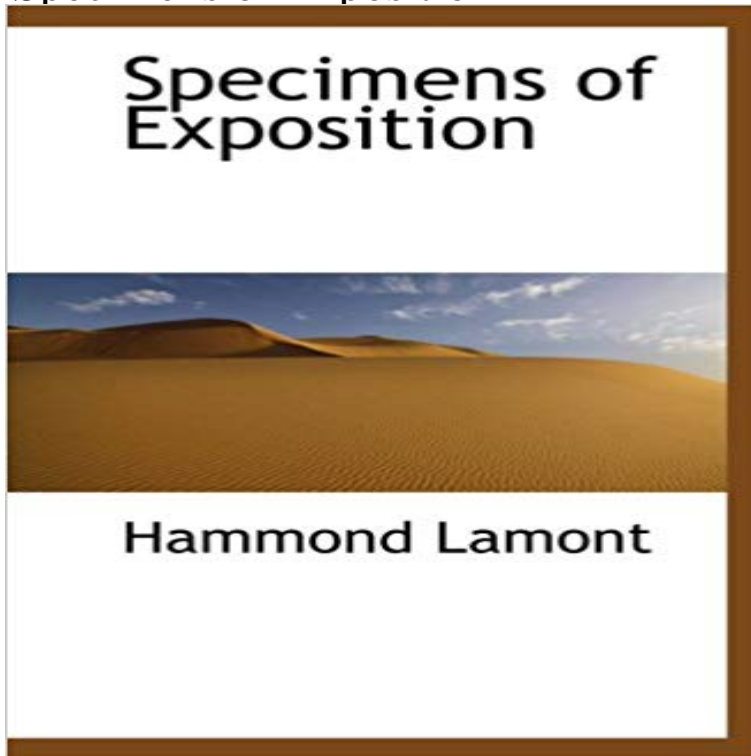


Specimens of Exposition
