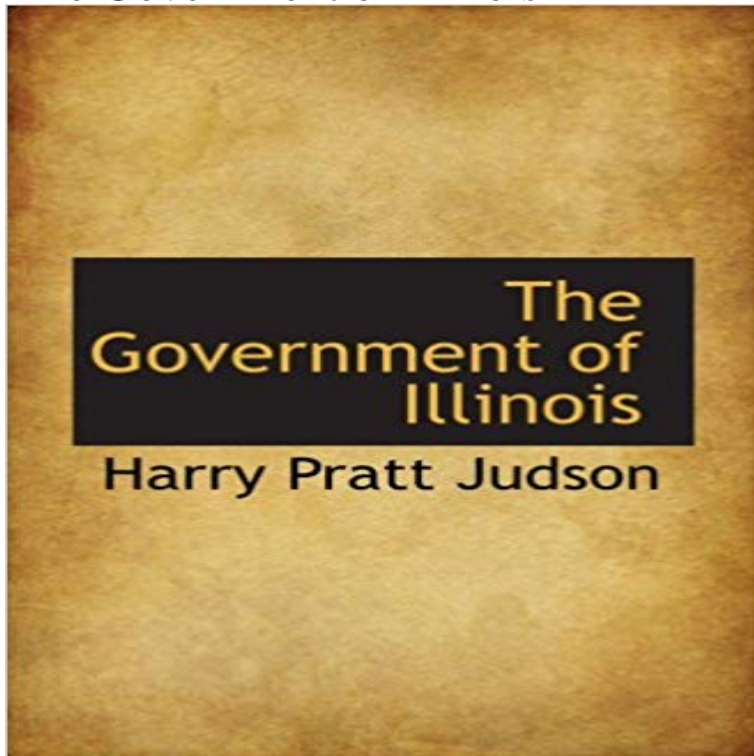


# The Government of Illinois
