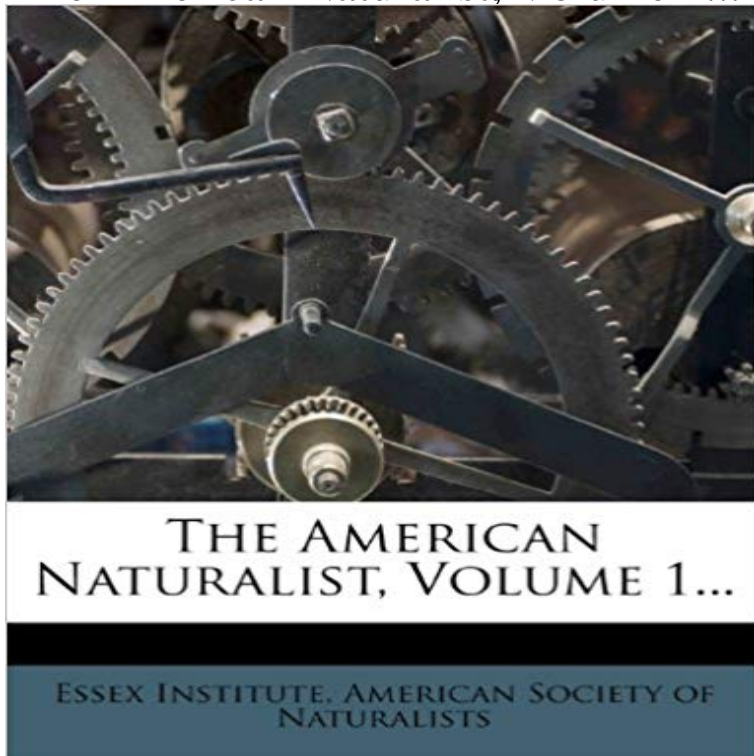


## The American Naturalist, Volume 1...
