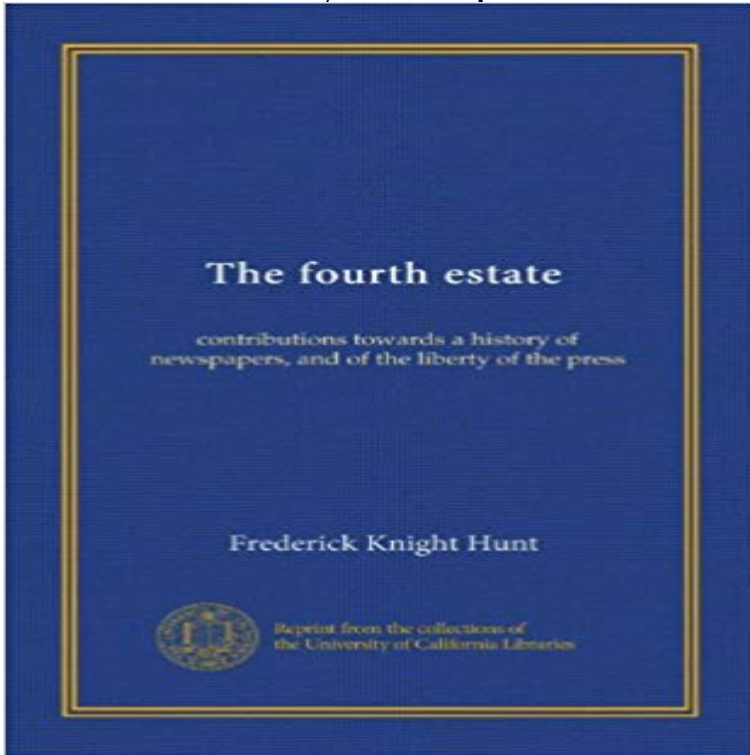


The fourth estate (Vol-1): contributions towards a history of newspapers, and of the liberty of the press
