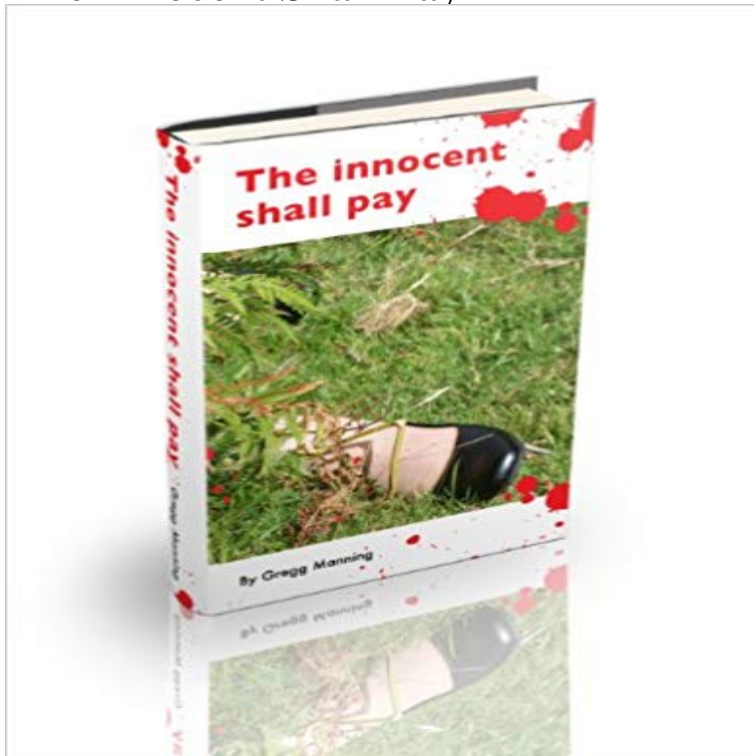


## The Innocent Shall Pay
