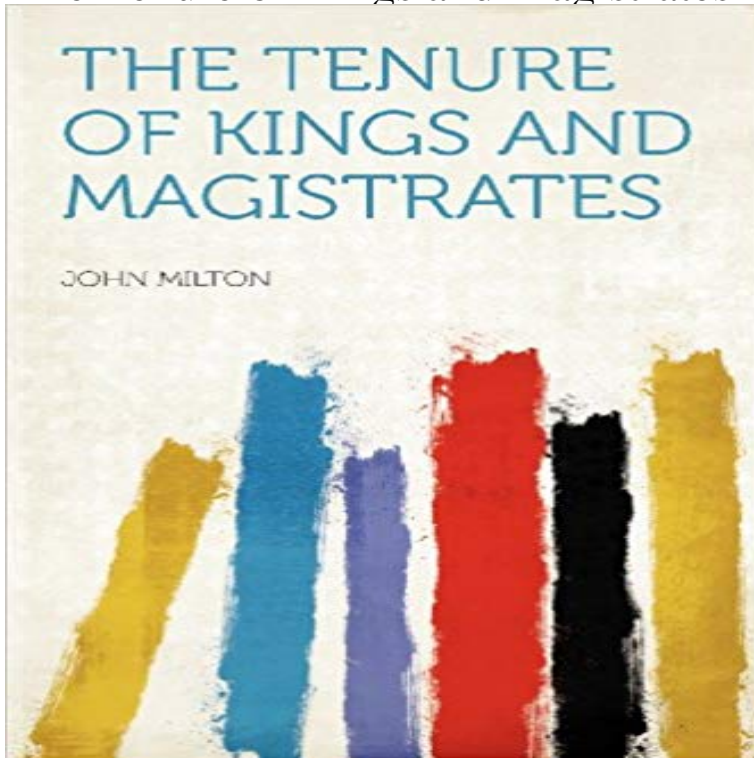


## The Tenure of Kings and Magistrates
