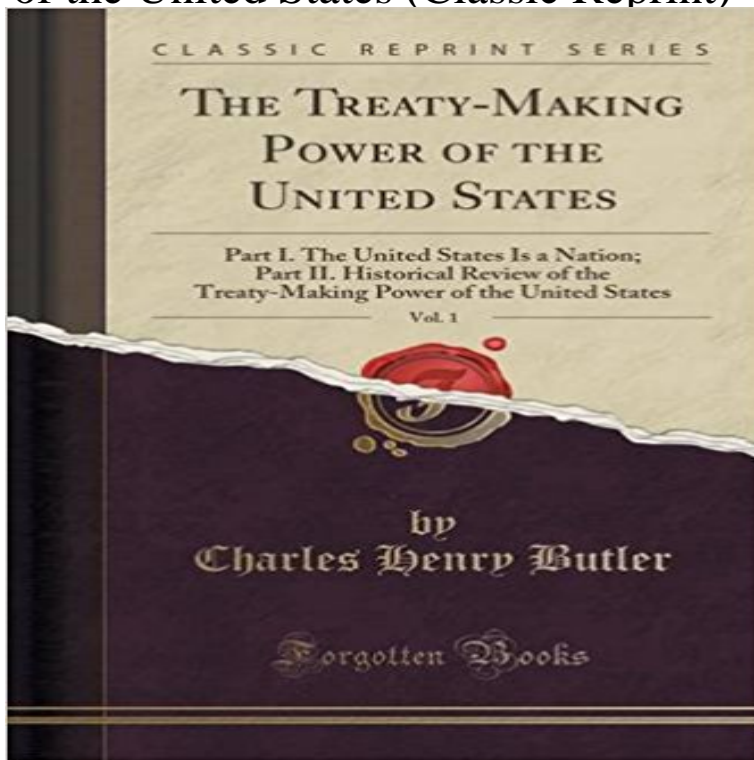

E. Treffrey whose ability as an analyzer and indexer of works of this nature has earned for him a well deserved reputation.
