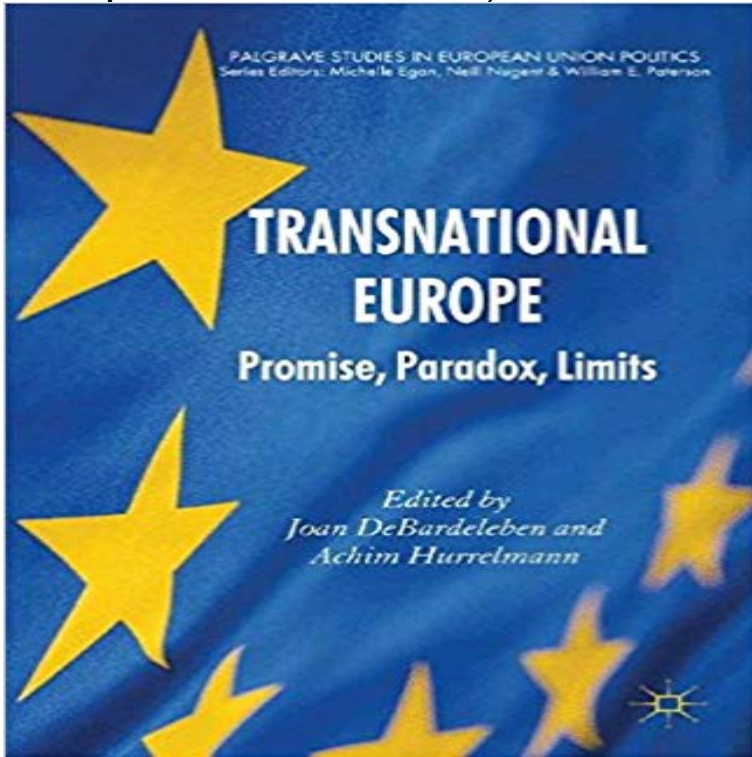


# Transnational Europe: Promise, Paradox, Limits (Palgrave Studies in European Union Politics)
