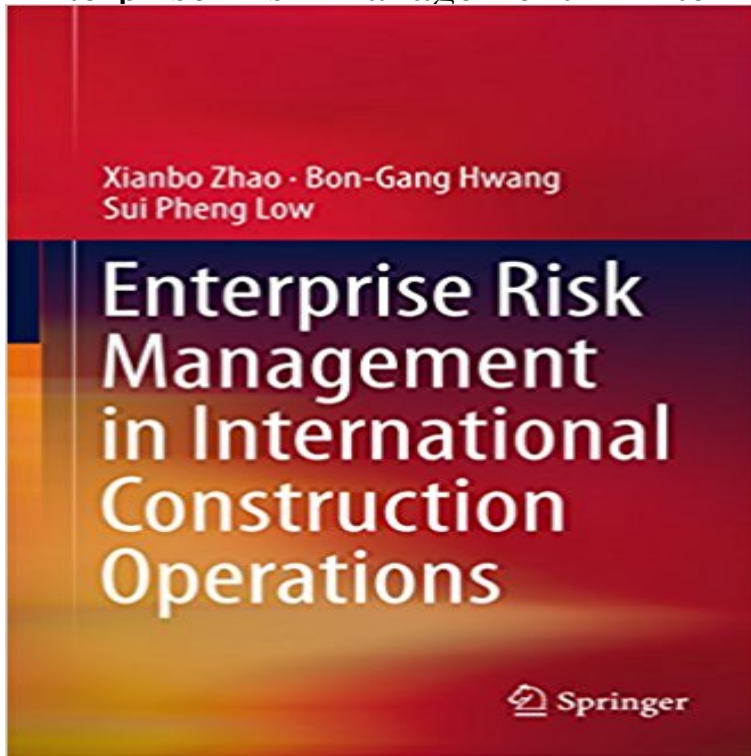


Enterprise Risk Management in International Construction Operations
